Dear Friends of the Natick Service Council:

We are closing out our Fiscal Year 2022-2023 and are pleased to present you with this Annual Report of the Council's activities and accomplishments. Our 61st year of operation was filled with challenges starting with the lingering effects of the COVID-19 pandemic along with high inflation that impacted all of us. Inflation, in particular, has had a significant negative impact on those Natick neighbors who rely on the Natick Service Council.

Once again, however, the Natick Service Council took on these and other challenges as we carried out our mission of working towards the day when every Natick resident's basic needs are fully met, and everyone in our community has the opportunity to improve their quality of life.

Through the generosity of our donors, we were able to help 801 families this year. 136 new families required assistance this year and we were able to help them all where they needed assistance the most. We added 33% more food pantry appointments to ensure nutritious food was available to everyone. Housing continues to be a significant roadblock to many in our community, and we were able to provide assistance to 384 families so that they could stay in their homes, as well as heat them. We provided 225 winter coats and sent 290 children in our community back to school with much needed supplies. We were also able to assist 28 members of our community find employment, helping them towards their goal of self-sufficiency. We could only do this through the dedication of our 207 volunteers, our partnerships in the community, and the incredible generosity of our donors.

While we increased the availability to all our programs this year, feedback from our clients told us that access to transportation was significantly impacting their ability to get to important appointments, find employment, and stay employed. In response to this call for help, we made the decision to start a transportation program. Through community partnerships, we arrange for rides and repairs to ensure our neighbors in need can get to work, shop at the food pantry, or keep doctor's appointments. Since the program's inception earlier this year, 34 of our households have used it to improve their daily lives.

As we conclude this Fiscal Year and look to the future, we at NSC remain forever grateful to all of those who have supported this organization and its mission over the years. We could not do what we do to ease the burden of day-to-day life on our neighbors in need without the support of this wonderful community we are lucky enough to call home. From our volunteers to our donors to our community partners, you make the Natick Service Council what it is today, and we are humbled to be part of an organization who makes "Neighbors helping Neighbors" our daily mission.

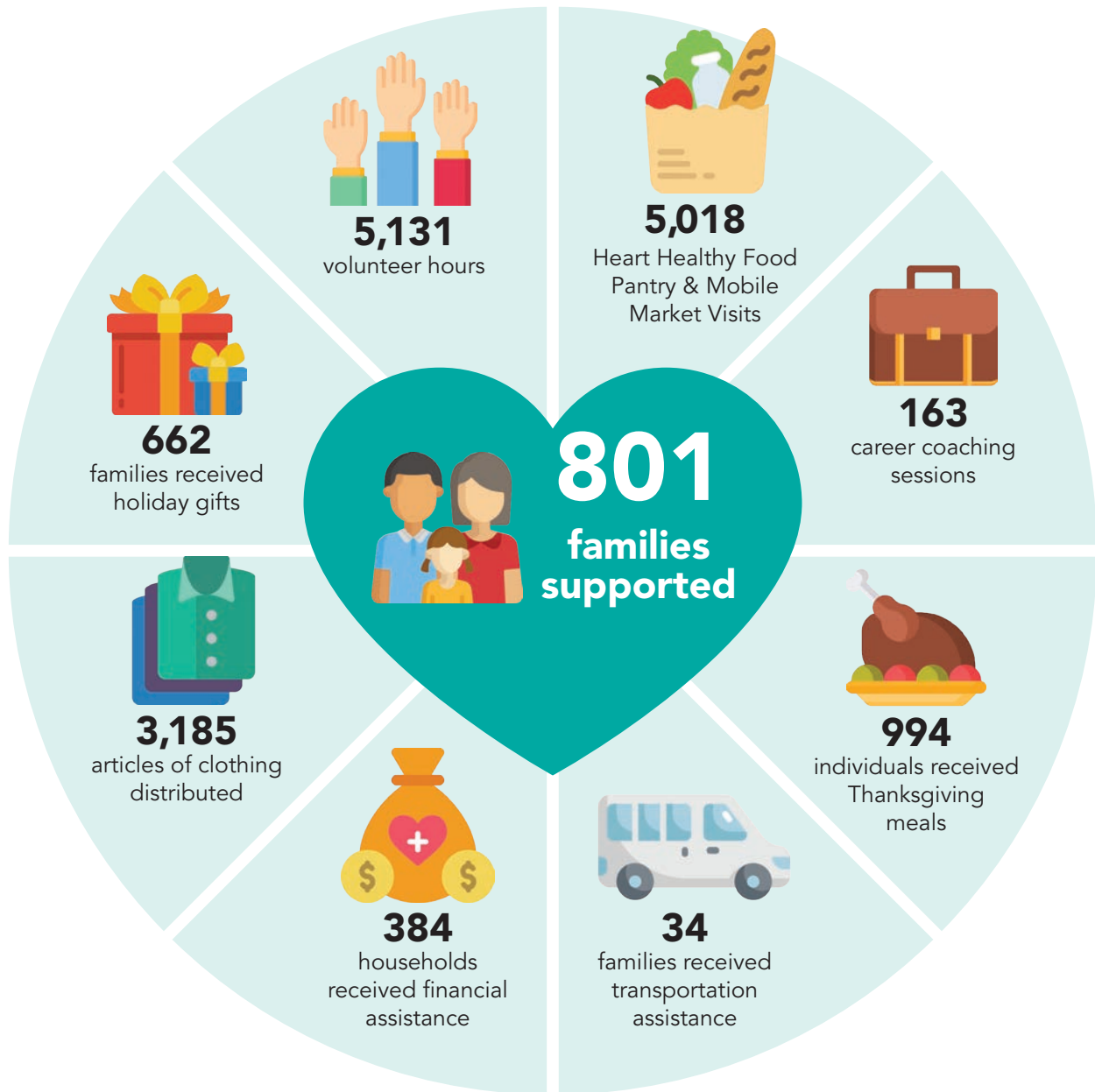

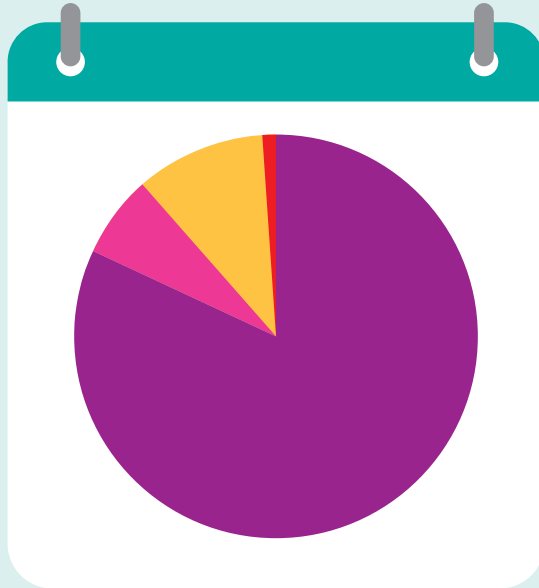

2023 Financial Report

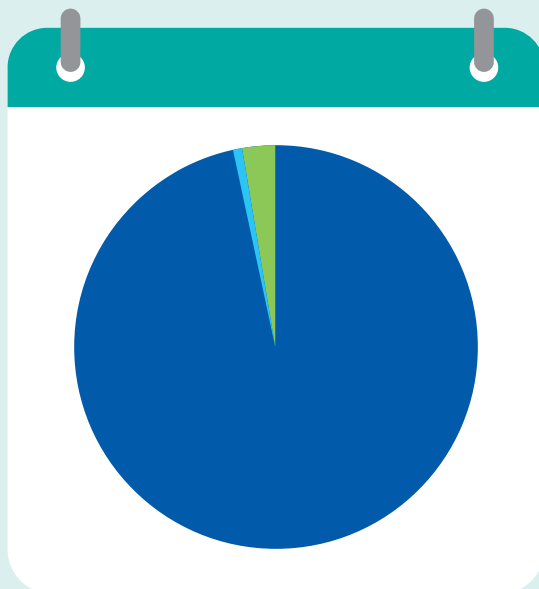
As a private, non-profit charitable organization, we rely solely on the generosity of the Natick community, including local residents, businesses, religious and civic organizations, and foundations.
